C. Consider Replacing Customer Driveway - Destroyed by City Leak

Discussion: The Public Works department destroyed a large portion of a customer's driveway to fix a steel line break underneath the slab. Superintendent would like to replace the driveway once they have replaced the steel line that runs underneath it.

D. ARPA- GrantWorks Contract

Discussion: The venue of litigation was changed from Travis County to Coke. Change was made and approved by City Attorney.

E. ARPA – Projects
