B. CPA Contract with Everett Bedford

- C. Housing Authority Board of Commissioners Appoint Kimberly Lewis Motion by Council Member Josh Tennison to appoint Kimberly Lewis to the Housing Authority Board of Commissioners. Seconded by Council Member Jonathan Torres. Vote 5-0, motion carries.
- D. USDA Application for Community Grant Motion by Council Member Mike Stephens to allow the City to apply for the USDA Community Grant. Seconded by Council Member Brantly Robertson. Vote 5-0, motion carries.
- E. 5-23 Nuisance Ordinance 1st Reading

Discussions: Changes were made to the Nuisance Ordinance to better clarify abatement processes and update legal verbiage at the end of the ordinance. Some changes include; Citizens who receive abatement notices can request a hearing in front of the Hearing Official prior to the abatement, If the property owner and their mailing address are unknown a notice of violation will be placed on the property which is in violation, The City will use the mailing address for property owners recorded with the Appraisal district, Repealer Clause, Saving Clause, and Effective date were all added to the end of the ordinance.

Motion by Council Member Jonathan Torres to approve of the 1st reading of Ordinance 5-23, Nuisance Ordinance. Seconded by Council Member Josh Tennison. Vote 5-0, motion carries.

F. 6-23 - Noise Prohibition Ordinance - 1st reading

Discussion: Updated ordinance with the Repealer Clause, Saving Clause, and Effective date section. Added a time frame for an ordinance to better enforce the noise ordinance. The schedule was presented as follows: Sunday-Thursday 9:00 am - 10:30 pm, Friday& Saturday 9:00 AM - 1:00 AM. Council requested that Friday and Saturday's 1:00 am cutoff date be moved to 12:00 am.

Motion by Council Member Mike Stephens to approve of the 1st reading of ordinance 6-23, Noise Prohibition with the changes to the time frame. Seconded by Council Member Brantly Robertson. Vote 5-0, motion carries.

G. 7-23 - Itinerant Vendors Ord - 1st reading

Discussion: Updated ordinance with the Repealer Clause, Saving Clause, and Effective date section. The ordinance added the definition of Open to the Public Function to exempt them from permit requirements. This includes functions like the Feed Store's farmers market or the events like the Shindig. Council would like to remove the number of vendors from the definition. Permit fees for Itinerant Vendors/Peddlers/Solicitors were increased to \$50 for the permit plus \$10 per employee.

Motion by Council Member Jonathan Torres to approve of the 1st reading of ordinance 7-23, Itinerant Vendors with the changes discussed. Seconded by Mayor Pro Tem Tracy Grantham. Vote 5-0, motion carries.

- H. 8-23 RV Trailers & Portable Housing 1st reading
 - Discussion: Updated ordinance with the Repealer Clause, Saving Clause, and Effective date section.
 - Motion by Council Member Mike Stephens to approve the 1st reading of Ordinance 8-23, RV Trailers & portable Housing. Seconded by Council Member Jonathan Torres. Vote 5-0, motion carries.
- I. 9-23 Sanitation Rates 1st reading

Discussion: Consider charging customers for a tire drive, potentially \$3.00 per tire. Sanitation cannot afford another free service on top of the Convenience Center and Curbside Pickup. Council does not want to charge for this event and would like to approach EDC for the project.

Motion by Council Member Mike Stephens to table this item until the project is presented to EDC. Seconded by Mayor Pro Tem Tracy Grantham. Vote 5-0, motion carries.

- J. 624 Commerce Street Property Donation
 - Discussion: Council denied the request to waive the cost of abatement, the property owner would like to donate the property to the City. The property donation form was submitted to the property owner's lawyer but has not been returned at this point.
 - Motion by Council Member Jonathan Torres to deny the donation of the property located at 624 Commerce Street. Seconded by Brantly Robertson. Vote 5-0, motion carries.
- K. Resolution 10-23 Cancelling the May 6, 2023, General Election Motion by Mayor Pro Tem Tracy Grantham to approve Resolution 10-23 to cancel the May 6, 2023, General Election. Seconded by Council Member Mike Stephens.
- L. One Time Waiver of Pet Registration fee with Rabies Vaccination
 Discussion: CEO Martha Grimes would like to set up a City Pet Registration at the Rabies clinic to allow citizens to register their animals with the City. The city would like to waive the pet registration fees for this event only to encourage more citizens to register their pets.
