F. City Property 923 Commerce Street-Food Truck

<u>Discussion:</u> A food Truck has been utilizing the parking lot in front of the Volunteer Fire Department without explicit permission from the property owner. Citizens have been concerned with this truck on the property since the truck uses the electricity at the Fire Department, which is paid for by the City. The owners of the truck were present to ask for permission to utilize the property since the property is owned by the city. The council is worried that if they allow the food truck to stay, it might set a precedent for other vendors wishing to utilize the location.

**Secretary** – City Hall Renovations are 80% complete at this time, the animal facility has started the process to be certified for euthanasia, on December 20<sup>th</sup> there will be an environmental assessment on 3<sup>rd</sup> Street for the TXCDBG Grant, a plan for a proposed retail building has been submitted to the City for the construction of a Dollar General on the corner of 10<sup>th</sup> and Austin.
