

RESOLUTION NO. 10-23

A RESOLUTION CANCELLING THE MAY 6, 2023  
GENERAL ELECTION AND DECLARING EACH  
UNOPPOSED CANDIDATE ELECTED TO OFFICE

WHEREAS, in accordance with the laws of the State of Texas, and the charter of the City of Robert Lee, a General Election has been ordered for May 6, 2023 for the purpose of electing four (4) Councilmembers to serve in the City Council in the City of Robert Lee; and

WHEREAS, the City Secretary has certified in writing (attached Exhibit "A") that each candidate on the ballot is unopposed for election to office; and

WHEREAS, the filing deadline on February 17, 2023 for placement on the ballot and February 21, 2023 for declaration of write-in candidacy has passed; and

WHEREAS, in these circumstances Section 2.053(a) of the Election Code authorizes a governing body to declare each unopposed candidate elected to office and cancel the election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROBERT LEE, TEXAS:

Section 1: THAT the Certification of Unopposed Candidates executed by the City Secretary is hereby accepted as presented in the attached Exhibit "A".

Section 2: THAT the following candidates, who are unopposed in the May 6, 2023, General Election, are hereby declared elected to the City Council, and shall serve a term of two years to said respective offices:


Section 3: THAT each candidate is subject to issuance of Certificates of Election; their signing of the Statement of Elected Officer, and to the taking of their Oath of Office after the May 6<sup>th</sup> election date.

Section 4: THAT in accordance with the Election Code, the City Council of the City of Robert Lee hereby cancels the General Election scheduled to be held on May 6, 2023.

Section 5: THAT the City Secretary shall post a copy of the Order of Cancellation (attached Exhibit "B") at the Coke County Courthouse, the designated polling place on May 6, 2023.


